- 7. The Quotations would be evaluated for all items together.
- 8. Award of contract:

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 8.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 8.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
- 9. Payment shall be made in Indian Rupees as follows:

Delivery and Installation - 90% of total cost

Satisfactory Acceptance - 10% of total cost

- 10. All supplied items are under warranty of **36** months from the date of successful acceptance of items and **24 months AMC**.

- 13. Training Clause (if any): The company should provide training of the specified equipment at the time of installation without any additional cost. Also training of concerned person/technician on site.
- 14. Testing/Installation Clause (if any): Vendor has to install the equipment in the lab space provided at his own cost and test the equipment.

SOFTWARE

The complete software must compatible with Win 8, 64 bit and should be an integrated pack to control the dosing of liquids, image analysis and evaluation of results.

Software to determine static and dynamic contact angles using sessile drop and captive bubble method, store and report measured contact angle values.

The software should be able to record the video images and should be able to trigger the camera for video recording. These video images are then analyzed frame by frame by the software automatically.

Software to determine surface free energy of solids from contact angle data. The surface free energy splits into its polar and dispersive components. Integral and extendable database with substance data of liquids which can be linked directly to the measuring data.

Software to measure the Surface and Interfacial tension of liquid-air/liquid-liquid interface by Pendent drop method.

Optional Accessories:

- 1) The system should have provision to install a top view drop image analysis system by top view distance method to measure the contact angle on concave surfaces.
- 2) The system should be upgradable to work with dual dosing system to make two drops and analyze both to them to calculate surface free energy in single click.
